## Dear Customer,

The purpose of this letter is to advise you that Naturelle Consumer Products Ltd have been made aware of an issue with mis-use of product which could present a risk to the user.

This FSN has been initiated due to advisory notice from the UKHSA that mis-use of alcohol-free cleansing wipes has been linked to Burkholderia Stabilis. These products are not sterile, and they are not intended for use as a pre-injection swabs or for cleansing of minor wounds.

## Recommended actions for distributors and customers:

• Stock held at distributors: Please stop sale of all stock and quarantine any unsold stock.

Please advise Naturelle (at the address below) of the lot numbers identified and quantity

of each lot remaining in your stock. We will arrange to uplift these and replace it with a sterile wipe.

- <u>Distributors communication to end customers</u>: Please contact all customers if possible and advise them to return or dispose of the product. They should confirm with you that this has been done and what quantity has been disposed/returned.
- Reconciliation requirements: You will need to track the quantity of wipes sold to each
  customer and compare to the number of wipes confirmed to have been disposed of or
  returned. These values should be shared with Naturelle on a weekly basis so that we can
  inform the HPRA.

Wipes used in first aid kits should be individually wrapped and sterile, in compliance with the British Standard BS8599-1.
