Dear Pharmacist,

We wish to advise you that the above-listed batches of Osteomel Once Weekly 70 mg tablets are being recalled with immediate effect.

This recall is going to **pharmacy level**. This action has been agreed with the Health Products Regulatory Authority (HPRA). As this is a pharmacy level recall, you are <u>not</u> required to contact patients to whom the above-listed batches have been dispensed.

The reason for the recall is due to out of specification results for the parameter disintegration identified in a number of batches.

We request that you please perform the following actions:

- Immediately quarantine any units of the above-listed batches which you have in your possession. For hospital pharmacists, this includes all stock at ward or clinic level. Please make relevant staff at your facility aware of the contents of this recall notification.
- Complete the customer return form overleaf indicating the quantity of each batch in your possession and whether you would prefer replacement or credit. Please email the completed form to recall@clonmel-health.ie to arrange pick-up and credit or replacement stock. Please include a copy of the customer return form with the returned units.
