This recall is going to **pharmacy level**. This action has been agreed with the Health Products Regulatory Authority.

The reason for the recall is that the above listed batches displayed out of specification results for particle size distribution.


Please carry out the following actions:

1. Please immediately quarantine any units of these batches which you have in your possession.
2. Please return the stock to the primary wholesaler, Allphar Greenogue, Ireland. Please contact recall@uniphar.ie to organise the return of stock. All stock returned within four weeks of the date of receipt of this letter will be eligible for credit.
3. If you have supplied units of these batches to any other wholesaler, please send a copy of this recall letter to them, requesting that they quarantine and return any unsold quantities of these batches to you.
