Dear Veterinarian,

We wish to advise you that the batches of products detailed in the above table are being recalled with immediate effect.

The recall is going to veterinarian level. This action has been agreed with the Health Products Regulatory Authority (HPRA).

The reason for the recall is that Amantadine products are for human use and are prohibited as a veterinary treatment, in accordance with Regulation (EU) 2022/1255.

We request that the following actions are carried out:

1. Please immediately identify and quarantine any impacted units of the above batches within your facility.
2. Please return quarantined stock to Uniphar by 08th July 2026 where full credit will be issued to you.
3. If you have supplied units from the above batches to any other veterinary clinic, please forward a copy of this recall letter to them, requesting that they quarantine and return any unsold quantities to you.
