Mil-Par

What Mil-Par Contains: Each 5ml spoonful contains: 300 mg of magnesium hydroxide and 1.25 ml liquid paraffin. The other ingredients include sodium hydrogen carbonate. See leaflet for further information.

How to Take Mil-Par: Do not give to children under two years of age. For oral use only. If desired, the dose may be mixed with half a glass of milk or water. **Adults (including the elderly):** Take 1 or 2 tablespoons (15 – 30 ml) before breakfast or at bedtime. **Children aged 7 years and over:** Take 1/2 to 1 tablespoons (7.5 – 15 ml) at bedtime. **Children aged 2 to 7 years:** Take 1 or 2 teaspoons (5 – 10 ml) at bedtime. Mil-Par should not be given to children except on medical advice.

Storage: keep out of the reach and sight of children.

Do not store above 25°C. Use within 28 days of opening.

PACKAGE LEAFLET: INFORMATION FOR THE USER

Mil-Par Magnesium hydroxide and Liquid paraffin

What Mil-Par is and what it is used for. Mil-Par is a sugar free oral suspension containing a gentle laxative and a lubricant which together ease the discomfort associated with straining and bowel movement. It is recommended for the temporary relief of constipation.

Before you take Mil-Par
DO NOT give or take Mil-Par if you or your child:

- Is allergic to magnesium hydroxide and / or liquid paraffin or to any other of the other ingredients (see section 'What Mil-Par contains')
- Suffers from an appendicitis
- Suffers from a blockage of the bowel (intestinal obstruction)
- Suffers from an inflammatory bowel disease such as crohn's disease or ulcerative colitis
- Suffers from unexplained pain in the stomach (abdomen)

Mil-Par must not be given to children under two years of age.

You Must Be Especially Careful. Tell your doctor or pharmacist Before Giving or Taking Mil-Par if you or your child:

- Suffers from kidney disease
- Finds swallowing difficult - accidental leakage can occur into the lungs - do not keep trying to take Mil-Par
- Has persistent stomach (abdominal) pain
- Feel the need to take laxatives every day

How to store Mil-Par

Keep out of the reach and sight of children.

Do not use Mil-Par after the expiry date shown on the label. The expiry date refers to the last day of that month. Do not store above 25°C. Use within 28 days of opening. Medicines should not be thrown away in normal household waste. Return any unused medicine to a pharmacist. This will help to protect the environment.

Further information

What Mil-Par contains: Each 5ml spoonful of Mil-Par contains the active ingredients magnesium hydroxide mixture 3.75ml and liquid paraffin 1.25ml.

The other ingredients are sodium hydrogen carbonate and purified water.

What Mil-Par looks like and contents of the pack:

Mil-Par is a smooth, white, opaque, oral suspension. Mil-Par is available in pack sizes of 100, 200 and 500 ml. Not all pack sizes may be available.

- Are on a 'low sodium diet' (Mil-Par contains 0.684 mg sodium per 5ml dose)
- Are under a doctor's care for any reason
- Are taking any other medicines. This means medicines you have bought yourself as well as those you have on prescription from your doctor
- Are pregnant, think you might be pregnant or are breast feeding.

Important information about some of the ingredients of Mil-Par

Mil-Par contains 0.684mg sodium per dose. To be taken into consideration by patients on a controlled sodium diet.

How to take Mil-Par

Always use Mil-Par exactly as indicated on this label. You should check with your pharmacist if you are not sure. For oral use only. The dose may be mixed with half a glass of milk or water if desired. Not recommended for children except on medical advice. Not recommended for children under two years of age. Do not continue to take this medicine for a long period of time.

Dosage instructions:

Adults (including the elderly): Take 1 or 2 tablespoonfuls (15 – 30 ml) before breakfast or at bedtime.

Children aged 7 years and over: Take 1/2 to 1 tablespoons (7.5 – 15 ml) at bedtime.

Children aged 2 to 7 years: Take 1 or 2 teaspoons (5 – 10 ml) at bedtime.

If you take more Mil-Par than you should speak to your doctor or pharmacist straightaway. Take your medicine or the pack with you so your doctor knows what you have taken.

If you forget to take Mil-Par don't worry, do not take a double dose to make up for a missed dose, continue with your usual dose at the next due time.

If your symptoms persist or you have any questions about taking Mil-Par, talk to your doctor or pharmacist.

Possible side effects are:

Inflammation and formation of lumps. Prolonged use may cause paraffin to leak from the anus. This may irritate the area.

Accidentally breathing in liquid paraffin may cause congestion of the lungs. If you notice these or any other side effects, stop use and tell your doctor or pharmacist.

Reporting of side effects

If you get any side effects, talk to your doctor, pharmacist or nurse. This includes any possible side effects not listed in this leaflet. You can also report side effects directly (see details below). By reporting side effects you can help provide more information on the safety of this medicine.

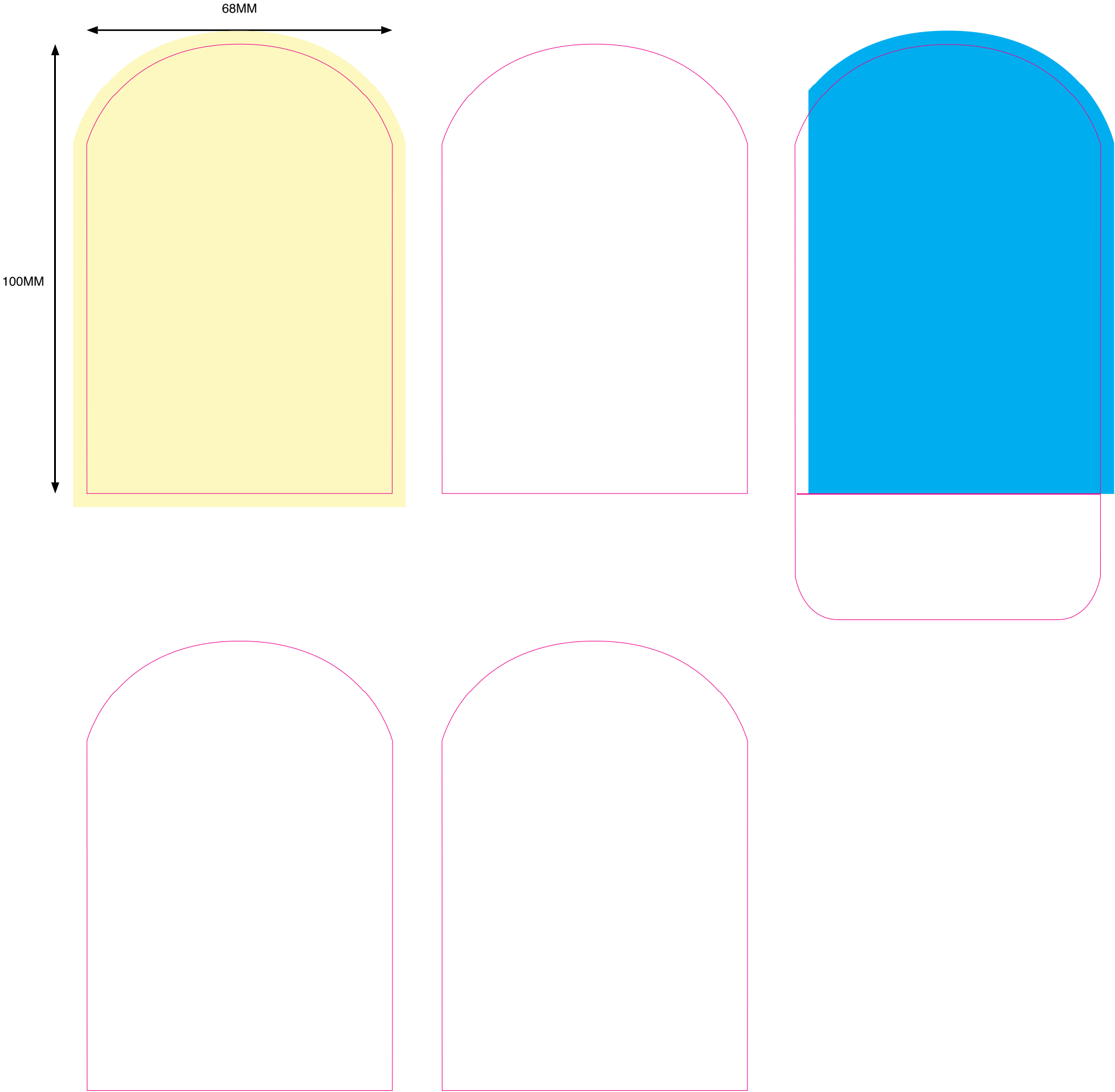
